9. Create actionable, site-specific Health Action Plans (HAP) that comply with International Finance Corporation (IFC) Performance Standards.
10. Deploy culturally sensitive, gender-responsive stakeholder engagement frameworks that elevate vulnerable and indigenous voices.
11. Architect sustainable post-mining considerations and closure plans that prevent long-term legacy health liabilities.
12. Formulate surrounding community health screening models and biomonitoring protocols to detect early chemical or environmental exposures.
13. Establish transparent, rights-compatible project grievance mechanisms to resolve community health complaints efficiently and maintain operational continuity.
